Expanding Furlough

- Compulsory Employer's contribution month by month:
 - July
 - August
 - September
 - October

Tapering off of CJRS

Month	Employer NIC & Pension Contributions covered?	Compulsory Employer's Contribution ?	Max % of wage paid under the scheme	Max Monthly £*
July	Yes	No	80	2,500
August	No	No	80	2,500
September	No	Yes: 10%	70	2,187.50
October	No	Yes: 20%	60	1,875

*Assumes 100% furlough
